NOTICE OF ELECTION

Notice is hereby given that:-

- (1) an election is to be held of a member(s) to the 47-Rajabala (Gen) Legislative Assembly Constituency;
- (1) nomination papers may be delivered by a candidate or any of his proposers to the Returning Officer in Office of the Project Director, DRDA, West Garo Hills, Tura or to the Assistant Returning Officer Shri P.R. Sangma, MCS in Room No. 2, Deputy Commissioner's Office, (Addl. Building), West Garo Hills, Tura between 11 AM and 3 PM on any day (other than public holiday) not later than the 8th October, 2021 (Friday);
