Affidavit to be furnished by the candidate before the Returning Officer for election to the Meghalaya Legislative Assembly from From 35 Langrin Assembly Constituency.

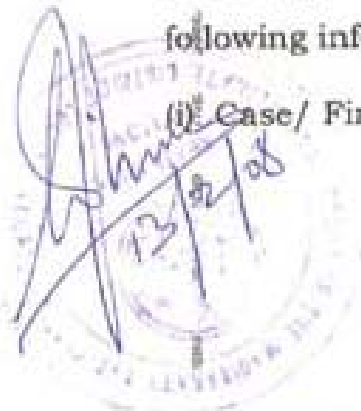
