2. In the Conduct of Election Rules, 1961, for Form 26 and the entries relating thereto, following Form and entries shall be substituted namely.

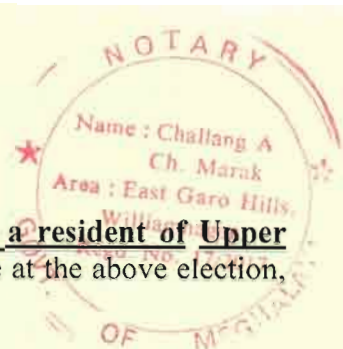
