S.O. 1732 (E) – In exercise of the powers conferred by section 169 of the Representation of the people Act, 1951 (43 of 1951), the Central Government, after consulting the Election Commission, hereby makes the following rules to amend the Conduct of Election Rules, 1961, namely:-

- (1) These rules may be called the Conduct of Elections (Amendment) Rules, 2012.  
(2) They shall come into force on the date of their publication in the Official Gazette.

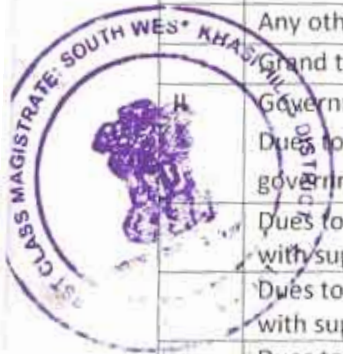
