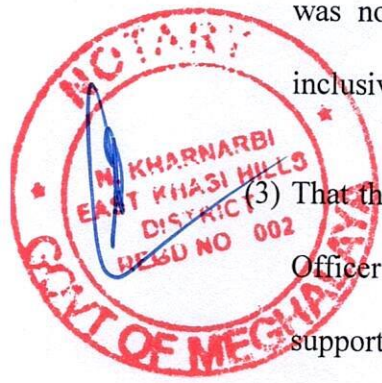

- (4) That the account of my election expenditure as annexed hereto includes all items of election expenditure incurred or authorised by me or by my election agent, the

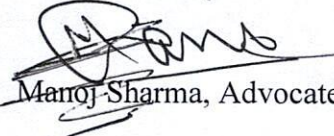

(6) That the statements in the foregoing paragraphs (1) to (5) are true to the best of my knowledge and belief, that nothing is false and nothing material has been concealed.

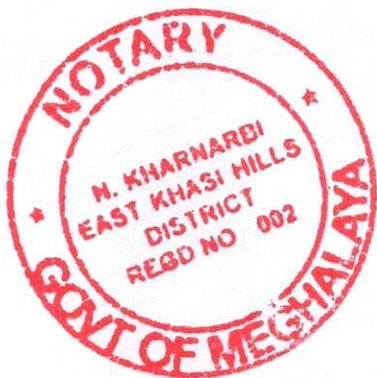

The difference to the tune of Rs 206164/- is noticed, in which an amount of Rs. 398515/- was recorded in the Shadow Observation whereas an amount of Rs. 192651/- only was mentioned in the Register of Expenditure maintained by you.

You are therefore required to furnish necessary replies for the understatement of expenditure recorded in the Register.

With respect to the subject cited above , I would like to inform you that as per records from the Shadow Register there is a discrepancy in the amount incurred by the candidate to the tune of ₹206164 difference. In connection to this I would like to state that the following:

1. That POL vouchers for Vehicles could not be produce at the time of Inspection i.e on the 9th Feb 2023.
2. That Hiring of Vehicles, Chairs, Tables etc were on a day basis whereas records in the Shadow Register was recorded base on every meeting. Hence hiring charges for the same items charged at every meeting ~~which~~ has made a large difference.

In this regard, I pray for kind consideration to look into the matter.
