SHOW CAUSE NOTICE

Whereas, the registration of an Association/Body of individual citizens of India as a political party is governed by the provisions of Section 29A of the Representation of the People Act, 1951; and

Whereas, the purpose of registration of an association as a political party with the Election Commission of India under the aforesaid Section 29A is stated in that Section itself, i.e. to avail of the provisions of that part for the purposes of the Representation of the People Act, 1951, which means participation in elections conducted by the Commission under the said Act; and

Whereas, the Political Parties herewith in Annexure A were registered as political parties under the said Section 29A, on an application made by the party under the said Section; and

Whereas, the current addresses of the said Political Parties are not known; and

Whereas, as per the records of the Commission, the said parties did not set up any candidate at any of the elections held, either to the House of the people or to any State Legislative Assembly or bye-elections for the last 06 years since 2019; and

Whereas, in view of the above, it is self-evident that the said parties has ceased to function as political parties for the purposes of the aforesaid Section 29A; and

Whereas, in the above circumstances, the Commission, in exercise of its powers under Article 324 of the Constitution of India and Section 29A of the Representation of the People Act, 1951, proposes to delist the Political Parties herewith listed in Annexure A from the list of registered parties; and

Whereas, before taking action as proposed above, the Commission has decided to provide to the said parties an opportunity of making a representation/showing cause, if any, as to why the proposed action may not be taken;

Now, therefore, the Political Parties listed in Annexure A are called upon to make a written representation to the undersigned on this behalf if they so desires. The representation, if any, should be duly accompanied by an affidavit from the President or General Secretary of the party, and all supporting documents on which the party proposes to rely, and should reach the undersigned latest by 26.08.2025.

It is also stated that the date of hearing for the party has been scheduled on 22.09.2025. Such hearing should mandatorily be attended by the President/ General Secretary/ Head of the Party. If no reply is received from the party by the aforesaid date, it will be presumed that the party has nothing to say in the matter and the Commission will pass appropriate orders without any further reference to the party.

Madam/Sir,

I am directed to refer to the subject cited above and to state that Political Parties are registered under provisions of Section 29A of The Representation of the People Act, 1951. After registration with the Commission, Political Parties are entitled to many benefits like:

- 1. Exemption from Income Tax (Under Section 13 A of IT. Act)
- 2. Recognition (Under Para 6 of Symbols Order)
- 3. Common Symbol Allotment for RUPPs under Para 108 of Symbols Order
- 4. Reserved Symbol for parties recognized under Symbols Order
- 5. Nomination of Star Campaigners

The purpose of registration of an association as a political party with the Election Commission under the aforesaid Section 29A is stated in that Section itself, i.e. to avail of the provisions of that part for the purposes of the Representation of the People Act, 1951, which means participation in elections conducted by the Commission under the said Act.

Over time, a large number of Political Parties have been registered. However, it has come to notice that many of the Registered Unrecognised Political Parties(RUPPs) have not contested even a single election for the last 06 years since 2019. A list of such RUPPs is enclosed at Annexure-A.

You are requested to serve a Show cause notice to the above-mentioned political parties and to get the notice published alongwith the names of the parties in the form of an advertisement in National and local newspapers. Further, wide publicity needs to be given in media and social media as well.

You are hereby authorized by the Commission to hear such parties and after giving opportunity of being heard to such political parties, you are requested to send a detailed report (as per proforma attached at Annexure-B) within a period of one month from the receipt of this letter.
